- (3) For students who are approved to complete an education program over a long term pursuant to the provision of paragraph 4, Article 4 of the Graduate School Regulations (hereinafter a "long-term study student"), the total amount of scholarship for the years usually required to complete the program (excluding the amount before being recognized as a "long-term study student") will be divided by the number of years that the student will remain in the program, and then provided annually. Any fraction less than 1,000 yen resulting from such calculation shall be rounded up to the nearest thousand yen, which will be arranged in the first year that the student receives this scholarship.
